Distinguished Alumnus Nomination Form

The Distinguished Alumni Selection Committee is seeking names of outstanding alumni to be considered for the "Distinguished Alumnus" citation. To be considered for this citation, an individual must meet the criteria listed below:

1. Must be an alumnus of the University
2. Must have achieved extraordinary distinction in his or her chosen business profession, life's work or worthy endeavor
3. Must be a person of such integrity, stature and demonstrated ability that the faculty, staff, students, and alumni will take pride in and be inspired by his or her recognition
4. Must be an individual who, in deeds and action, reflects and recognizes the importance of his or her education at Texas A&M University-Commerce or its predecessor, who demonstrates pride in the Alma Mater and whose interest and loyalty are evident

Any alumnus who meets the eligibility requirements may be nominated for the award by any of the following individuals:

1. Any member of the Alumni Association or Foundation
2. Any member of the Texas A&M University-Commerce faculty or staff
3. Any member of the Distinguished Alumni Chapter
4. Any alumnus of the University

Nominations must be received by the Office of the President no later than October 1, of the previous calendar year. Each nomination will be considered for a maximum of three years from the date of most recent nomination.

Any individual shall be ruled ineligible to receive the award if any of the following conditions prevail at the time the Selection Committee meets to consider the nomination:

1. Candidate for public office or serving in an elected state or federal public office
2. Serving on the Board of Regents of the Texas A&M University System
3. Holding office in the Texas A&M University-Commerce Alumni Association or Foundation Board
4. Doing business with the University
5. Employed by Texas A&M University-Commerce

If you know of any alumnus who you believe to be eligible, you are requested to complete this form and forward to the Office of the President. Please note the confidentiality of this matter.
